## Help Improve the Way Montpelier Works ... Vote for a State Auditor Who Will Look Out for You!

Although we have all appropriately been focused these last many months on the unique challenges presented by our COVID-19 crisis, I feel we need during this election season to ask why Montpelier has failed to address problems that have been literally decades in the making. Let's highlight just a few of them.



Earlier this year we all saw the headlines around the near failure of the *State College System*, a victim of many years of fiscal neglect. And just last December many Vermonters were likewise surprised to learn of the *profound crisis existing in our State prison system*.

There are still other issues that haven't made the headlines.

Our fellow citizens are only beginning to hear about the massive **\$4.7 BILLION hole** that Vermont taxpayers will need to fill to cover our public employee pension and retiree healthcare obligations. Few Vermonters are aware as well that we rank **next to last in the U.S. for our government ethics programs.** 

Our representatives in Montpelier have a shared responsibility to pay attention to the basics, such as educating our students, securing health and retirement benefits and providing adequate government infrastructure – and that goes for our State Auditor.

Consider this. In his 8 years in office, the incumbent State Auditor has:

- not attended 22 of 23 State College System audit committee meetings and has never addressed the system's chronic underfunding
- chosen to ignore our public pension and retiree healthcare shortfalls
- missed important opportunities to take a significant leadership role as to government ethics, to include looking into questions of government complicity in the EB-5 scandal
- not addressed our inadequate prison system and how we have consistently underserved our female prison population

The current Auditor seems to have selected for audit and examination issues of ideological interest to him or issues that have relatively small impact on the lives and well-being of Vermonters. The State Auditor must always be a **true fiduciary** for the people. That means that the Auditor's attention has to remain on the most intractable, difficult and practically "unfixable" of our issues – not issues that match the Auditor's personal interests given his background as a career political consultant.

It takes a certain fearlessness to take on the biggest of our challenges. As a CPA and a public auditor by profession, I know what it takes to do the job. I pledge that as your Auditor I will be

tenacious. I will not be a "one-and-done" Auditor. I will do the work. If deficiencies aren't fixed, I will stay on them no matter the challenge.

It's time for a change. It's time to improve the way Montpelier works.
